DECREE OF APPOINTMENT

Greetings in the Lord!

Wishing to provide more fully for the good of the people of God in the Archdiocese of Seattle, with confidence in your qualifications and character, and after consulting with the Priest Personnel Board, I do hereby appoint you in accord with canon 545 of the *Code of Canon Law*.

You are expected to assume the duties and responsibilities, as well as to enjoy the rights and privileges of this office, in accordance with the universal law of the Church, local statutes, and approved customs. Further, to all to whom it may concern, we recommend that they recognize you as Parochial Vicar and give you all necessary assistance.

Your term of office as Parochial Vicar takes effect on June 30, 2007, and ceases on June 30, 2010, or prior to that time through other provisions of law (canons 184, ff.).
